Bostik Quick Stick is a white, water-borne adhesive, supplied in the form of a solid stick for quick, easy and clean application. #### Preparation

1. Ensure the surfaces to which the adhesive is to be applied, are clean and dry.
2. Always open and use adhesives over protected work surfaces.
3. Remove the cap and turn the tube base to slightly extend the glue stick.

#### Application

1. Apply the glue with firm even strokes.
2. Wind glue stick back down into dispenser.
3. Remove any excess glue from body of stick with a clean tissue.
4. Replace the cap after use.

#### Cleaning

1. Excess adhesive may be removed with a damp cloth.
2. Adhesive on clothing may be removed with water before the adhesive dries.
