However, Xerox has concluded that the presence of titanium dioxide in this mixture does not present a health hazard. The IARC classification is based on studies in rats using high concentrations of pure, unbound TiO2 particles of respirable size. The titanium dioxide in this mixture is dispersed in a liquid and is not expressed as "free" titanium dioxide. Therefore, this classification does not apply to this product.
